ELIGIBILITY:

The competition is open to all artists 18 years or older living in MA working in 2D encaustic. Work must be original.

SIZE RESTRICTION: No piece larger than 32 x 40 inches (this includes frame if piece is framed)

ENTRY PROCESS:

Entries should be submitted as jpg files on CD. Digital image size should be approximately 1200 x 1800 pixels, which is 4" x 6" at 300 dpi. Work submitted must represent the actual work to be delivered to the gallery. Artists may submit up to three images. File name should be the artist's last name with first initial and 1, 2, or 3.

i.e.: **Smith.L.1.jpg** Entry CD will not be returned. **The gallery reserves the right to reject any work that it feels was not represented accurately.**

FEE: There is a non-refundable fee of \$35 for up to 3 submissions. **Please make check payable to Gallery Seven** and submit it with the cd and an **Entry Form**. (See Below)

LIABILITY: **Gallery Seven** is not responsible for damage to work submitted, although care in handling can be assured. Works will be insured, for the artist's percentage of the retail price, for fire and theft while at Gallery Seven. Gallery Seven **WILL NOT** insure the work while in transit or if the work is not retrieved by the pick up dates listed below.

SALES:

Exhibited work will be available for sale. Gallery Seven will retain a commission of 40% on all sales that occur during the exhibit. The balance will be paid to the artist at the end of the show and will include a statement listing work(s) sold. Artist agrees to allow accepted work to remain with the exhibit until the close of show.
